Terms of Use

BS GLOBAL INVESTMENT 365 later known as BS GI 365

1. Acceptance of Terms

The Service is offered subject to acceptance without modification of all of the terms of this Agreement, including the Privacy Policy and any document incorporated by reference. Policies published by BS GI 365 from time to time or additional terms (for example, the terms applicable to service providers such as VersaPay) are incorporated by reference.
